



Shook Hardy Lands Bicoastal Trial Team From Carlton Fields

Weisburd earned his law degree from Stanford Law School, holds a Master of Laws from the University of Cambridge and has a bachelor's degree from the University of California, Los Angeles.

Cobbs, who joins the Shook Hardy general liability litigation practice, was chair of the mass tort and product liability practice at Carlton Fields, the firm said. He represents manufacturers in mass tort and product liability litigation in industries including consumer, automotive, chemical and pharmaceutical, the firm said.

Cobbs told Law360 Pulse Thursday that in addition to having a longtime best friend who has worked at Shook for years, he has developed relationships with a number of firm attorneys as they "did different work for the same clients over the years."

"It just made sense," Cobbs said. "I have a ton of respect for them, and working with them has given me a really good sense of the culture there, the people, which was really important to me. Also, their national reach makes sense for my practice and the others who've joined with me."

Cobbs practiced with Carlton Fields for more than 17 years before making the move to Shook Hardy, according to his LinkedIn profile. Before entering private practice there, Cobbs clerked for two years for a Florida federal judge.
