Law360 Names Practice Groups Of The Year

Law360, New York (December 20, 2015, 9:48 PM ET) -- Law360 would like to congratulate the winners of its Practice Group of the Year awards, given to those firms that came through for clients by sealing the biggest deals and securing wins in high-stakes litigation.

Now in its sixth year, the Practice Group of the Year series drew 730 submissions in 2015. A record 184 winners were selected across 30 practice areas for honors. More firms than ever received Practice Group of the Year awards this year — 80 firms have been honored, up from 69 firms last year.

For the third consecutive year, Gibson Dunn led the pack with 10 wins, followed by Kirkland & Ellis LLP with nine and Latham & Watkins LLP with eight, landing these firms the elite Firms Of the Year distinction. Honorable mention was given to heavyweights Skadden Arps Slate Meagher & Flom LLP, which brought in seven wins; Covington & Burling LLP, which earned six honors; and Davis Polk & Wardwell LLP, Quinn Emanuel Urquhart & Sullivan LLP and Sullivan & Cromwell LLP, which racked up five awards apiece.

Several firms won awards in four categories. They are Arnold & Porter LLP, Cleary Gottlieb Steen & Hamilton LLP, Debevoise & Plimpton LLP, King & Spalding LLP, Orrick Herrington & Sutcliffe LLP, Sidley Austin LLP, Simpson Thacher & Bartlett LLP, Weil Gotshal & Manges LLP and Wiley Rein LLP.

Leaders in the high-stakes litigation categories are Gibson Dunn, which won for Class Action, Competition, Employment and Securities; Morgan Lewis & Bockius LLP, which won for Class Action, Employment and Environmental; and Quinn Emanuel, which scored wins for Appellate, Class Action, Product Liability and White Collar.

The firms that led in the corporate categories this year are Kirkland & Ellis and Simpson Thacher, which both won in the Capital Markets, M&A, Private Equity, and Real Estate categories. Several firms scored awards in three corporate categories this year, including Cleary Gottlieb, Fried Frank Harris Shriver & Jacobson LLP, Davis Polk, Skadden and Sullivan & Cromwell.
