



## **Leading Class Action Litigator Moves to Shook**

**SAN FRANCISCO ( September 6, 2018)** Prominent class action attorney Andrew J. Trask has joined forces with litigation powerhouse Shook, Hardy & Bacon. “In particular, privacy and data-related breaches can affect just about any business, whether a manufacturer, retailer or financial institution,” said Trask.
